Minutes: Minutes from our last meeting in August meeting were approved.

Meeting was opened led in prayer by John Mullin.

<u>Grand Knight's Report: (John Mullin)</u> John reminded everyone that Bob Lodding sent out a request for volunteers to staff the parish picnic that will be held on September 25.

John asked Ed Christian to give the council an update on the Rockers' Concession activity. Ed reported that the Rockers games will be ending next week and noted that we still have open slots for this activity. To date Ed reported that we have raised \$2650. He also that we had 7 participants for the Wake Forest Touch Down club event and expects that we will receive at leaste \$1400 for this effort. Ed also reported that Major League Soccer (MLS) will be coming to Truist field in the future and that, that should create addition fundraising opportunities.

Mike Ilderton (Financial Secretary) reported that he received a 'Food for Families' certificate from Supreme for fraternal year 2022. This certificate was presented to past grand knight Alex Papp by John Mullin (GK).

Financial Secretary's Report: (Mike Ilderton) Mike presented the prepared budget for the 2nd review. Included in the budget is the funding for the parish's 75th anniversary.

Membership: (Ed Christian)

Ed asked John Mullin to report on the results from the parish stewardship weekend. John reported recorded the names of 5 knights that would like to transfer into our council and 9 potential prospects. John sent emails inviting 3 of the potential transferees that provided their email address to attend this meeting and forwarded the full list to Ed Christiaan (membership) and Tim Knorr.

UNFINISHED BUSINESS:

It was noted that the 25th annual golf tournament to benefit the Oblates retirement fund was held today and a report from Rick Boedicker is expected in the October meeting.

The motion from last month's meeting 'that the Council sponsor the 75th Anniversary Site and Reception in the amount of \$10,000' was amended to include the phrase to read 'that the Council sponsor the 75th Anniversary Venue for the Mass and Celebration at the High Point University Conference Center in the amount of \$10,000'. This was made by Mike Ilderton, seconded by Ken Demato, and approved unanimously.

A motion to approve the budget as presented by Mike Ilderton, was made by R. V. Wakefield, seconded by Ed Christian, and approved unanimously with one exception by Ed Christian.
